- Need to paint in entryway of Dogwood where there was a water issue.
- Discussed section of grass near hot tubs. We could save money if we seeded with wildflower seeds. It takes a lot of weeding and hard to cut. Jason to find out want is the best time is to seed.

#### Motion

Bryan Lyerly made motion to seed grass near hot tubs with wildflowers. Jim Westmoreland Seconded. Motion passed unanimously.

#### **Employee Housing**

Board wants to look at raising rent. Bryan will do a walk through with Billy. We need to notify the tenants about walk through and also let them know they can have nothing out front.
