Tommy and Fred,

The Board approved \$3500 for implementation of the ARC-GIS system in a Board meeting on May 9. I had said the cost of the system was \$3500 and 900/yr. The meeting minutes have an error indicating \$35,000. (Kat please correct).

As a reminder the ARC-GIS system creates an on line inventory and geo location map of all water co infrastructure. This is necessary to help locate and maintain infrastructure (pumps, valves, etc) as well as creates the ability to maintain an accurate inventory of our parts and aid in projecting end of life for maintenance and budgeting purposes. SGM would use the data captured during the engineering study completed in 2020/21.

Attached is the final firm quote. Costs have increased to \$5500, annual costs have reduced to \$550.

I motion that we accept this bid and proceed with implementation.
