#### Old Business

- FY2021/22 Budget (Operating and Capital)
  - o Bill MacFarlane noted that the Board recommended increasing wages line 10% to attract more staff.
  - Action Items:

    - Bill MacFarlane will read the AMA and send out verbiage to Board for management fee and accounting fee.

- LTR Waiver and Owner FAQ Legal

- Salih noted that the Board needs to go back to the attorney to draft the legal wording to present to the Owners for the Annual Meeting.
- o Salih noted that the simpler the vote is for the amendment of the declaration, the easier this will be.
- O Dave Robson noted that if a decision is made to limit occupancy for renters in units, then it could be a form of discrimination.
- Action Item: Bill MacFarlane will reach back to Altitude Law to see how much this LTR issue will cost so the Board can adjust the budget as needed.
- o It was noted that if the majority of ownership doesn't vote to change Section 12.8 of the declaration than the LTR discussion will be eliminated.
- o Reagan inquired about the remedy for noise violations. The Board noted it is eviction.
- Salih noted that once questions are dialed-in, communication will be sent to all owners.
