## Call meeting to order and establish quorum

• Salih Varoglu called the meeting to order at 4:02 pm and established a quorum with 4 out of 5 Board Members present.

#### Old Business

1. SEFRA was discussed and recent invoice for \$6,461.75 (attached)

**Motion** – Salih Varoglu motions to pay SEFRA if they complete the project and sign a mutual release agreement with the HOA. In addition, Sefra agrees that this is the final payment and provides the board with the executed contract signed by Dave Robson while HOA President, also signed by Sefra.

**Vote** – 4-0

**Resolution** – Motion passes unanimously.

2. Discussion on if the board can recommend or mention Back at the Ranch (BATR) as a choice for owners to work with for FF&E replacement for their residential units. They will receive a 20% discount, local manufacturer warranties, free delivery and work with a local company in Gunnison,

**Resolution** – Motion passes unanimously.

3. Mutual release agreement was discussed and board agreed they should seek legal guidance on drafting the agreement between SEFRA and the HOA.

**Motion** – Salih Varoglu motions to approve CBMR Properties the permission to reach out to Altitude Community Law, David Firmin, to have him prepare a mutual release agreement.

Second –Bryce Miller seconds.

**Vote – 4-0** 

**Resolution** – Motion passes unanimously.

4. Grand Lodge FF&E (furniture update) letter and email drafted by Salih Varoglu was discussed

**Motion** – Salih motions for approval from the board to send a revised letter via email to all homeowners pending legal guidance from Altitude Community Law in Motion 2 above, explaining that the Board gives up on The List process, presenting Sefra package to owners but not as a part of The List and mentioning BATR if within Board authority. **Second** –**Bryce Miller** seconds.

**Vote – 4-0** 

**Resolution** – Motion passes unanimously.

**ACTION** – CBMR Properties to create a generic HOA FF&E email address for all owners to send their residential unit furniture replacement items to the board for approval.
