### Adoption of New Policy related to: Parking Rules

- **Motion** Salih motioned to adopt a policy which revises paragraph 18 of the Grand Lodge Rules and Regulations as below:
- 18. No vehicles may be stored on a long-term basis at Grand Lodge Crested Butte. Each Unit is entitled access to one overnight parking space only while the Unit is occupied. If a room is

not occupied, Owner or Owner's authorized representative(s) may request and receive a room key and one temporary parking pass to visit the room for inspection, maintenance, cleaning, delivery or other needs. Owner or Owner's authorized representative need not stay overnight.
